To contest the rejection of your Claim, by the response deadline above, you must send us a signed written statement that states your reason(s) for contesting the rejection of your Claim, along with any supporting

documentation. If the dispute concerning your Claim cannot be otherwise resolved, your Claim will be presented to Lead Counsel and/or the Court for resolution.
