The Settlement Administrator will review any information you submit in response to this determination. If there remains a dispute concerning the Settlement Administrator’s determination of your Claim, the dispute will be presented to the Court for binding resolution.

Class Counsel will file a motion for Court approval to distribute the Net Settlement Fund after claimants have had an opportunity to respond to the determination from the Settlement Administrator and all Claims have been finalized. The distribution motion will be posted on the Settlement website

(www.MGBAntitrustSettlement.com). Any disputes concerning the determination of your Claim will be filed in connection with the distribution motion. The distribution motion will be posted at www.MGBAntitrustSettlement.com after it is filed with the Court.
